P.)** as a **sustainable constitutional legal and economic solution**, and the **4th Generation of Finance (4GF)** as a **conventional legal and economic alternative**, led by **ACEIDD (IECASD)**, a partner of our national association **ACEIDD**.

These perfectly **innovative** concepts for promoting **sustainable development** appear to us as the model, accompanied by the appropriate means that suit us for **Cameroon** and **Africa**. Therefore, we fully subscribe to the three pillars of its implementation, namely:

E. P.**) and the **4GF (4th Generation Finance)** the **solution and alternative development** for developing countries, especially without increasing **their already suffocating debt levels**.
